



1. Most of the rooms are around 400sqft only. Two of the class rooms are in the adjacent building.
2. Laboratories are not equipped with required equipment, specimens and consumables. Laboratories facilities needs to improve.
3. Books in the library are not arranged properly. Most of the books are test papers only. More text books should be added to the library and instructed to procure journals.
4. Two FD's Worth of Rs.1,20,000/- should be renewed.
